## Board of Directors Meeting Held April 28, 2021

The topics discussed are as follows. We will discuss in more detail at the annual meeting so all residents can participate in the discussion and ask questions.

- ❖ Architectural Committee: 1) The Schneiders have hired new builders to complete the house on Lot 32. Progress is being made, with potential move-in for fall. It was mentioned neighbors would like the front of the house completed first with rough landscaping in place so from the road it does not look like a construction site. 2) Bo Carneal offered to volunteer on the committee.
- ❖ Maintenance Committee: 1) With Fred Hall's resignation, Tim Krohe will be taking over maintenance concerns with the assistance of Jeff Povtak. Tim is working on a mowing schedule. 2) The lot at the bottom of Windridge Parkway has been cleaned up. Vehicles stored there must have permission, and be licensed and cared for.

#### ❖ New business:

- *Internet* 1) Blue Ridge Towers has won the contract for Franklin County. They will be contacting Roanoke County regarding our Roanoke County residents. They plan on building a tower at Windy Gap Elementary with a relay tower either behind WGMV water tower or behind the pavilion. Fiber optic line will be laid on the right-of-way. Residents can opt in at no cost upon initial installation. If residents opt to hook up at a later date, there will be a "nominal" fee. 2) Starlink satellite may also be available 4<sup>th</sup> quarter 2021.
- *Covenants*--There was much discussion about some neighbors' dismay over excessive tree removal on some properties. We would like to remind all residents to be familiar with our written covenants. The Board has had private conversations with those involved.
