Committee Reports:

Architectural Review (Pennye Epperly)

Schneider House – Workers have been at the house daily. Builder anticipates completion in the fall. Owners expect completion by end of the year. Also, the owners complied with request to have port-a-pot moved from front of house.

Richter Lot 17 – Owners are still working on final house plans and site plan for position of house. HOA board did not approve variance request but did approve preliminary house plan.

Maintenance (Tim Krohe, Brian Heatwole)

Tree of Heaven — Tim, Jeep, Brian Heatwole, and Bo worked hard (with some assistance from others) to remove more than 20 Ailanthus trees from multiple properties. Special thanks for their hard work! Mowing and Leaf Removal – Thanks to all for your patience regarding mowing. Mr. Powell now has assistance and the mowing has improved. He also blew the rest of the leaves out of the gutters. Contact Tim if you have any questions or concerns about the mowing.

Road Paving – Road repaving in our neighborhood is no longer in the 2024-2025 state budget and is under consideration for future - Brian H. is intermittently monitoring. Also, Brian/Tim have identified some tree branches over the roadways which may pose scratch risk to some vehicles. They plan to contact some homeowners to offer select pruning along their lots.

Treasurer (Brian Taylor)

"Our largest expense is mowing and leaf removal. While Tim and Brian have done a great job of negotiating a low rate from our contractors, these and a few other expenses have been going up due to inflation. While I am recommending that we do not raise our HOA dues this upcoming year, our

expenses will almost certainly exceed our income from our HOA dues by an estimated \$1500 this year, causing us to run at a deficit. However, we believe that there is enough reserve in our savings accounts to cover these higher expenditures, at least for the time being. For that reason, I am proposing that we keep our annual dues at \$300/year, at least for the near future, and we can re-assess this in upcoming years as our savings are reduced."

Becky moved to accept the 2024 budget and several seconded the motion. Budget for 2024 has been accepted.
