Update on Schneider House:

Tree trimming/removal request:

## Maintenance Committee

Leaf Blowing/Removal:

There have been a few complaints regarding leaf blowing, as in some cases leaves were blown back up onto properties rather than being removed. Tim and/or Brian H. will contact Mr. Powell regarding clarification of leaf removal as opposed to leaf blowing.

### Mowing:

It would be helpful to the mowers if you would keep the right of way clear of limbs/debris to facilitate easier mowing and leaf removal. We realize that there is still a lot of debris as a result of the ice storms. Tim will request that Mr. Powell give us a week's notice prior to our first mowing of the spring.

Brush vs. Bulk Pickup for Roanoke County Residents:

Becky has recently spoken with Roanoke County regarding pickup. Bulk refers to anything other than yard debris. The County has been overwhelmed with brush pickup due to the storms last month and will endeavor to pick up as often as possible. They are due to pick up brush and bulk items every two weeks.

### Road repaving:

Brian H. will contact Vdot to determine whether their budget allows for our neighborhood streets to be repaved this year. He will also discuss with them the removal/trimming of dead trees along Windridge Parkway.

## **Budget Report**

HOA fees will remain the same. Approximately 40 percent of property owners have paid their dues, which are due by June 1<sup>st</sup>.
